

Exhibitor Information updated 3.23.2023

#### Admission

- a) The Kentucky Horse Park charges \$6.00 per entry through the parking booth, or exhibitors may opt to purchase an event pass **\$18.00** upon arrival on park grounds.
- **b)** Exhibitors wishing to tour the Kentucky Horse Park may purchase reduced park admission tickets at the parks Visitor Information Center.

## Parking / Traffic

- a) NO PARKING is permitted in the stabling areas, arenas, grass or any other designated NO PARKING areas. Violators will be ticketed and towed.
- b) Exhibitors should park their empty trailers and horse vans in the marked areas in the Trailer Parking lot or other designated parking areas as assigned. Loading and unloading of vehicles in the stabling/show area is permitted.
- c) No camping is permitted in any of the barn or arena areas. Trailers and RVs requiring this service should make reservations with the Kentucky Horse Park Campground.
- d) Horses and carriages have the right of way on all roads and paths.
- e) Please adhere to posted speed limits, which differ throughout the park. This is enforced by the Kentucky Horse Park Police.
- f) Hall of Champions Road is closed to all event traffic, **including horses**, golf carts, mopeds, and bicycles. No event traffic should enter the main visitor area of the park.
- g) All drivers of any vehicles on the Park must be at least **16 years of age** and have a valid driver's license. This includes golf carts, scooters, mopeds, etc.
- h) The Kentucky Horse Park does not allow four-wheelers, three wheelers, or dirt bikes over 70 cc on park property.
- i) The Kentucky Horse Park reserves the right to revoke golf cart privileges from any exhibitor for violations or abuse.

# **Camping**

- a) The Kentucky Horse Park Campground accepts reservations. Exhibitors should call Reserve America at 1-888-4KY-PARK (888-459-7275) or make reservations online at Reserve America
- b) Exhibitors also have the option of staying in the Kentucky Horse Park Tent City. This is a small campground located near the Covered Arena on the show grounds. Availability is on a first-come-first-



serve basis. Upon arrival, exhibitors will need to check-in and make payments at the Kentucky Horse Park Campground. Occasionally, Tent City is not available due to conflicting events.

- c) No camping is allowed in the stabling area, around the show rings, covered arena, or any other nondesignated area.
- **d)** Showers are available on grounds in the rest rooms located next to the horse show office and bathhouses at the Campground.

### Stabling

- a) Stabling is in 10x10 shed row-style permanent stalls.
- b) Additional space is not available for tent temporary stabling at the discretion of the park.
- c) Exhibitors not requiring stabling who are showing out of their trailers will need to park in the designated day-trailer parking area. Show management may make arrangements for additional space if needed.
- d) No temporary equipment may be permanently attached to any existing Kentucky Horse Park property such as signs, barricades, stabling, trees, etc. Staples, nails, and/or screws of any kind are not allowed.

## **Early Arrival/Late Departure**

- a) Exhibitors wishing to utilize stabling prior to or following a show should contact the show management to inquire about availability, if available stalls are charged at \$50 per stall, per day. The Kentucky Horse Park will invoice events directly for early arrival or late departure.
- b) Horses remaining in stalls after 8 a.m. the day following an event will be charged a layover stabling fee outlined above.
- c) The Kentucky Horse Park will attempt to accommodate all requests for early arrivals or late departures, however, events must adhere to the dates of available stabling as stated in the event contract. <u>Early arrival and/or late departure stabling is subject to availability due to other events.</u>
- d) Horses occupying early arrival or late departure stabling are not authorized in any Park Arena, ring or other facilities. No horses in early arrival or layover stabling may be ridden on park grounds unless a certificate of insurance is on file.



# **Electrical Appliances**

In compliances with the State of Kentucky Fire Code, the Kentucky Horse Park does NOT allow any of the following in stalls, barns or tents:

- a) Any 2 prong plug appliances
- **b)** Any 2 prong plug extension cords
- c) Light duty cords for indoor use
- d) Any 3-way adaptors unless specifically made for outdoors
- e) Any adaptors without 3-prong connections
- f) Appliances such as Microwaves, coffee makers, refrigerators, air conditioners, etc.
- g) Any Fans used must have 3 prong connections (2 prong to 3 prong adapters are not authorized).

#### **Paddocks**

Paddocks are available for rental through the Dever Show Services office located next to barn 21. They can be reached at 859-233-9702.

## **Bedding**

- a) Wood shavings and straw are considered the only acceptable forms of bedding.
- **b)** Bedding can be pre-ordered through Dever Show Services at 859-233-9702. Exhibitors should contact Dever Show Services at least 24 hours prior to their arrival to make arrangements.
- c) Exhibitors may also bring their own bedding with them.
- d) No outside supplier may bring bulk bedding, feed or hay onto park grounds for resale.

#### Muck

- a) The Kentucky Horse Park will clean all stalls prior to exhibitor's arrival and following exhibitor's departure.
- b) All muck generated during event must be dumped in marked muck areas. Competitors who fail to adhere to marked muck dumping areas may be asked to leave the park.

#### Feed

- a) Feed and hay can be pre-ordered through Dever Show Services at 859-233-9702. Exhibitors should contact Dever Show Services at least 24 hours prior to their arrival.
- b) Exhibitors may also bring their own feed and hay, but no outside supplier may deliver or sell onsite.



### **Horse Requirements**

- a) All horses entering Kentucky Horse Park grounds must have valid proof of negative coggins test (within 12 months). A 30 day certificate of veterinary inspection is required for all horses arriving from outside the state of Kentucky. All horses considered Kentucky based must have a certificate of veterinary inspection dated within 12 months. Horses who fail to provide appropriate paperwork upon arrival will not be allowed to unload on park grounds.
- b) The Kentucky Horse Park requires all horses/ponies/mules be treated in a humane manner in accordance with various state and local humane society guidelines. Show management is expected to enforce fair and human treatment for all horses participating in an event at the park.

### Dogs

- a) Dogs are authorized on the park grounds.
- b) All dogs must be leashed (not to exceed 6 ft. in length) and under control of handler at all times, or suitably restrained in a tack stall, etc. Local animal control authorities will remove loose dogs at the owner's expense.
- c) Dogs left in cars, trailers, etc., will be removed at the owner's expense.
- d) Dogs are NOT authorized in any indoor facility at the Kentucky Horse Park to include the Alltech Arena, Club Lounge, Hospitality Rooms, Exhibit Halls, etc.

#### **Golf Carts**

- a) The ability to use a golf cart is a privilege, not a right.
- b) All drivers must be at least **16 years-of-age** with a valid driver's license.
- c) Golf carts are NOT authorized in any tourist areas of the park.
- d) Golf carts must adhere to traffic laws and posted speed limits.
- e) Golf Carts can be rented through Dever Golf Carts located next barn 21 and can be reached at 859-233-9702.
- f) The Kentucky Horse Park does not allow four-wheelers, three-wheelers or dirt bikes over 70 cc on park property.
- g) John Deere Gators, mules or similar rural rate vehicles are accepted.
